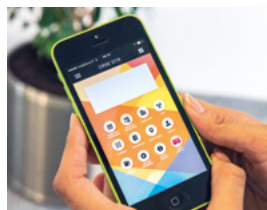

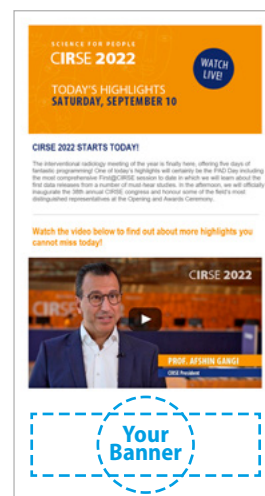

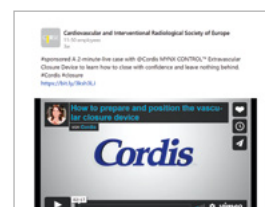

Eligibility Criteria
